## Radiance Cheerleading Player-Parent Contract:

Player-Parent Contract Parents and Players must sign this agreement that they have read the rules below and agree to them, sign and remit prior to the first scheduled practice. Agreement must be signed or handed in with your registration form and deposit. Our goal is a safe, fun, and positive season for all. The best way for us to accomplish this is to put down in writing our exact expectations up front. It is imperative you read this contract and agree to all terms prior to joining this season.

#### **TEAMS - PLAYERS**

All athletes require dedication and commitment to the season. Our training & competition phase is extensive but it will make you better, increase cheer knowledge, and improve your skill level. Our goal is to develop respect, discipline, commitment, and a positive self-image in each of the athletes. It is important that each player understands the concept of being a part of a "team."

Every athlete will be expected to conduct themselves appropriately at all times. You will be representing your family, as well as your community. Show respect at all times to coaches, teammates, judges at competitions & parents. Be competitive, but not disrespectful toward other teams. Disrespect to anyone will not be tolerated!

#### **PRACTICE - COMPETITIONS**

Understand that practice and training is where you receive the most instruction and experience. The "coaching decision" is not up for debate or question. Athletes must be willing to do any position needed by the team.

Occasionally there will be last minute practice cancellations due to inclement weather. We will give as much notice as possible if a practice must be moved or rescheduled.

We request that Radiance Cheerleading be a priority afterschool. We are looking for athletes who are committed to reaching their potential and who is willing to work hard to achieve this. Arrive to practice at least 15 minutes early. Appropriate practice wear is to be worn at practices, this is mandatory (T-shirt, Spandex Shorts, sneakers, Sports Bra etc.). Athletes must wear their hair up.

Radiance Uniforms will be worn to competitions. All athlete's hair and make-up must be done prior to competition arrival as well. It is the parent's responsibility to arrange travel for their child, if they can't attend.

#### PARENTAL REQUIREMENTS

All Radiance information will be communicated through E- Mail or direct communication with the Coach via text/call, and GroupMe. In order to be kept informed, make sure you check your email, GroupMe and texts regularly.

Parents are not to "Coach" their Athletes during special sit in practices or competitions. The Athletes will need to be focused on what the Coach has to say and need to concentrate on such. Parents are not allowed in the practice area unless the Coach specifies there is a special sit-in practice to see your athlete's progression. Parents are to be supportive of the entire Team at all times. Parents are not to engage in any behavior in



cheering that would reflect negatively on Radiance Cheerleading. Parents should engage in no-direction cheering, limiting their comments to encouraging their child and other players from both teams. Guidelines for Parents are no different from Athletes in this regard.

All remaining payment are due as noted on the published payment schedule. REFUNDS: There will be no refunds. Understand that our expenses must be paid on time, and we expect the courtesy of payment from parents on time. Season Fees paid to Radiance Cheerleading are non-refundable. There is no credit or refunds for athletes who are unable to attend competitions, athletes who are removed from our program, or athletes who choose to discontinue our program.

#### **GRIEVENCE PROCEDURE**

The following grievance procedure is designed to allow the coach to work with athletes while respecting the wishes of their parents. We encourage the athlete to talk to the coach when they have a problem if they are unclear about what the coach expects from them either in practice or in a competition. If the athlete is not ready to discuss the concern, the conversation should be delayed until the athlete is ready to do so.

When parents have a problem that is specific to their own athlete, we also encourage them to first talk to the coach. What coaches will not do is discuss "coaching decisions." "Coaching decisions" include, among other things, specific routine decisions. The coach will not be required to defend their thought process or conclusions in these determinations, and it is improper for a parent to request it. Please note again that "coaching decisions" are not, in our opinion, legitimate concerns. Specifically, the procedures to follow if you as a parent, or your athlete as a member of Radiance Cheerleading, have concerns about policies or actions, are, in this order: The athlete should speak to or meet with the coach about the matter. If the matter remains unresolved, or if the athlete has reasonable concern that speaking to the coach will not resolve the matter, the parent should speak to or meet with the coach. Parents and/or athletes are expected to call the coach on the phone to set a meeting. Meetings are to be at times and locations other than competitions. If a parent during a competition approaches a coach, the coach is required to refuse to discuss any controversial matter, and to walk away from the parent. The recommended time for a parent and/or athlete to talk to a coach about a problem is a previously arranged meeting time either before or immediately after a scheduled practice. Meetings should be previously arranged. Meetings will not be scheduled during or at a competition site. Asking uninvolved persons to take sides in an issue is unfair to the third party and to our cheer program. Competitive team athletics, by its very nature, creates situations where everyone may not be happy all the time. For the psychological health of the teams and the program as a whole, grievances need to be handled between the parties involved and the decision-makers in the situation. Any member who is approached and asked to listen to or express an opinion about matters between two other parties in the program is strongly encouraged to refer the complaining party to take the matter up with the coach in question. Repetitive complaining by the athlete(s) or other third parties that interferes with the programs efforts to pursue its stated pledge and purpose may be cause, in the sole determination of the program, may be asked to be removed from the program.
